#### 1. **Chief Executive Officer** (CEO)

An Engineering /Science and Technology/ Other post graduate from any accredited and nationally reputed institute/university having Minimum 2 to 4 years of overall work experience, with at least 1 to 2 years of experience in the start-up / Innovation /Entrepreneurship domain, either as a start-up founder / co-founder / core team member /key employee of a start-up and / or as an enabler of start-up/Innovation ecosystem or in a lead position in reputed Innovation & start-up promoting organization.

- A) Desirable Skills for above Post
- a) For Engineering- An Engineering Post graduate with prior experience in any streams related to Manufacturing/IoT/Agriculture /Bio-Technology /Sensor Technology /Instrumentation Automation/ Nanotechnology/ Information Technology sector will be useful.
- b) For MBA -A MBA from AICTE accredited MBA program from national and international accredited institutes or higher degree with relevant experience may be given added advantage.
- c) For Other Post Graduate- A Candidate who have helped startups/Incubators to scale up through funding/market development and allied means will be preferred.
