The Right to Information Act 2005, 22 of 2005 has been enacted by the Parliament and has come into force from June 15, 2005. This Act provides for "Right to Information" for citizens to secure access to information under the control of public authorities, in order to promote transparency and accountability in the working of every public authority. According to UGC guideline, all Universities and Colleges established by law made by Parliament or by State Legislature or by notification by the appropriate Government or owned, controlled or substantially financed directly or indirectly by funds provided by the Government shall come within the purview of a public Authority under the Act. Since Dayanand Arya Kanya Mahavidyalaya, Nagpur of Arya Vidya Sabha is "Grant-in-Aid" category: Section 4(1) (b) of RTI Act 2005 is applicable to college. The statutory declaration is displayed on College website.

Our college is strictly for girls, which is registered under Societies Act of the Government of Maharashtra. The college has a governing body which runs as per rules and regulations made by the Government of Maharashtra from time to time.

All the cells and committees of the institution are under Statutory Bodies and come under section 4(1)(b) of RTI Act 2005.
