### AGENDA SECTION-1

**1.01(a)** To confirm the minutes of the 491<sup>st</sup> meeting of the University Grants Commission held on **21<sup>st</sup> January**, **2013**.

The Minutes of the 491<sup>st</sup> meeting of UGC were confirmed with the following amendments in item 2.1:-

"The members of the Revisit Committee Prof. A.N. Rai, VC, NEHU and Prof. Vivek Suneja, Pro VC, University of Delhi were also invited to the meeting. After due deliberations, it was agreed that API may continue to be an objective system for screening the candidates both for the purposes of direct recruitment and promotion. The recommendation of the Revisit Committee on exemption to Ph.D. candidates from NET/ SLET was discussed but the discussion remained inconclusive".

  - (i) To report the inclusion of 59 Colleges (as approved by the Chairman, UGC) under Section 2(f) and 12(B) of the UGC Act, 1956 between 01.01.2013 to 31.01.2013.

(ii) To ratify the issue regarding extension of e-payment for disbursement of the fellowships through Canara Bank.

Noted and approved.

Further, it was resolved that the amount of fellowship paid upfront to the bank for disbursement should not be kept floating in the bank as interest earned on the float would accrue to the custodian bank and that is against the Government policy on financial prudence. Instead of paying the entire fellowship amount upfront, only the requisite amount as against the fellowship holders who have already registered may be paid to the bank and the balance paid as and when eligible / selected beneficiaries of the fellowship amounts register. While doing so, it may be ensured that no beneficiary should suffer from non-receipt of fellowship amount.

### SECTION-2 (MATTERS RELATING TO STANDARDS)

The Commission resolved that the rates prescribed by the Ministry of Health & Family Welfare should be followed and the amount sought for by AMU may be released on account. Further, the commission observed that the norms for funding medical colleges may be evolved.

The Commission resolved that only those foreign institutions which are accredited with the highest grade in their homeland should be allowed to collaborate with those Indian institutions which are also accredited with the highest grade by the recognized Indian

accrediting agencies.

of Expenditure, Ministry of Finance may be obtained.

To consider the Report of the Expert Committee which visited the Chennai off-campus centre of Vellore Institute of Technology (Deemed to be University), Vellore, Tamil Nadu to consider its inclusion under the ambit of the Deemed to be University.

To consider the request of Manipal Academy of Higher Education (MAHE), (Deemed to be University) to rename the institutions started without the approval of UGC as Schools and merge these institutions in the constituents units approved by the Government of India, MHRD.

The Commission deliberated on the proposal regarding the request of MAHE, an institution deemed to be university with regard to renaming of the institutions started by it, without approval of the UGC, as schools and merge these institutions in its approved constituent units. The Commission noted that during the course of the review in 2009 it was found that MAHE had started the following constituent units without the approval of the UGC –

- a) Manipal Institute of Management, Manipal (1999)
- b) Manipal Institute of Jewelry Management, Manipal (2005)
- c) Manipal Institute of Communication, Manipal (1994)
- d) Manipal Centre for Information Science, Manipal (1998)
- e) Manipal College of Allied Health Sciences, Manipal (1998)
- f) KMC International Centre, Manipal (2005)
- g) Manipal Institute of Regenerative Medicine, Bangalore (2007)
- h) Manipal College of Nursing, Mangalore (2007)

MAHE has now proposed to rename the above institutions [except the institution at (f) above] as under –

- a) School of Management, Manipal Institute of Technology Manipal
- b) School of Jewelry Management, Manipal Institute of Technology Manipal
- c) School of Communication, Manipal Institute of Technology Manipal

- d) School of Information Science, Manipal Institute of Technology Manipal
- e) School of Allied Health Sciences, Kasturba Medical College, Manipal
- f) Institution closed
- g) School of Regenerative Medicine, Manipal Multi Campus at Manipal Hospital, Bangalore
- h) School of Nursing, Kasturba Medical College Mangalore

The Commission took serious note of the lapse on the part of MAHE. However, from records made available in UGC, it was gathered that the institution deemed to be university (MAHE) was already granted approval for conducting the courses by the institutions mentioned at (a), (c), (d) and (e) above in 2004. Accordingly, the Commission approved the renaming of these institutions by MAHE. Further, in respect of the institutions mentioned at (g) and (h), permission was sought from UGC by MAHE but was not accorded. The Commission, however, approved the renaming of these institutions by MAHE keeping in view the nature of the courses conducted by these two institutions.

The Commission, however, rejected the proposal of the MAHE with regard to the Institute of Jewelry Management.

NISWASS was granted a seed money of Rs. 20 crore and a recurring grant of Rs. 4.91 crore per annum. There have been a number of irregularities in the utilization of funds by the institute as pointed out by the Sathyam Committee which was set up to enquire into the complaints against the organization.

The Commission resolved that NISWASS be asked to submit the utilization certificates of the grants already given to it and that no further grant of any kind be given to NISWASS.
