# Separate Audit Report of the Comptroller & Auditor General of India on the Accounts of University Grants Commission for the year ended 31 March 2013

We have audited the attached Balance Sheet of University Grants Commission (Commission) as at 31 March 2013. the Income & Expenditure Account and Receipts & Payments Account for the year ended on that date under Section 19(2) of the Comptroller and Auditor General's (Duties, Powers & Conditions of Service) Act, 1971 read with Section 19(3) of the University Grants Commission Act. 1956. These financial statements include the accounts of six Regional Offices of the Commission. The UGC has also established six IUCs. Of these ROs and IUCs, accounts of two IUCs were audited along with the UGC. These financial statements are the responsibility of the Commission's management. Our responsibility is to express an opinion on these financial statements based on our audit.

- 2. This Separate Audit Report contains the comments of the Comptroller and Auditor General of India (CAG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards and disclosure norms, etc. Audit observations on financial transactions with regard to compliance with the Law, Rules & Regulations (Propriety and Regularity) and efficiency-cum-performance aspects, etc., if any, are reported through Inspection Reports/CAG's Audit Reports separately.
- 3. We have conducted our audit in accordance with auditing standards generally accepted in/India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on a test basis, evidences supporting the amounts and disclosure in the financial statements. An audit also includes assessing the accounting, principles used and significant estimates made by management as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.
- 4. Based on our audit, we report that:
  - We have obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purpose of our audit;
  - ii. The Balance Sheet, Income & Expenditure Account and Receipts & Payments Account dealt with by this report have been drawn up in the format as prescribed by the Government of India, Ministry of Finance.
  - iii. In our opinion, proper books of accounts have been maintained by the Commission in so far as it appears from our examination of such books.
  - iv. We further report that:

#### A.1 Liabilities

# A.1.1 Current Liabilities & Provisions (Schedule 3)-Rs. 33.73crore

The above does not include unspent grant of Rs. 493.66 crore (Plan: Rs. 427.13 erore and Non-Plan: Rs. 66.53 crore) resulting in understatement of Current Liabilities and overstatement of Corpus/Capital Fund by similar amount.

#### A.2 Assets

#### A.2.1 Current Assets, Loans and Advances(Sch-S) - Rs. 1071.65 crore

- (i) The above includes accrued interest of Rs. 2.11 crore on GPF FDRs (Schedule-5) instead of Rs. 3.40 crore. This had resulted in understatement of Current Assets as well as Income for the year by Rs. 1.29 crore.
- (ii) Similarly, in the case of CPF FDRs (Schedule-5) the Commission had shown accrued interest of Rs. 1.05 lakh instead of Rs. 2.12 lakh. This resulted in understatement of Current Assets as well as Income for the year by Rs. 1.07 lakh.

#### A.2.2 Fixed Assets (Sch-4) - Rs. 5.98 crore

- (i) The above do not include value of 0.75 acres land allotted by M/o Urban Affairs and Employment. Non-accountal of land resulted in understatement of Assets as well as Capital Fund.
  - Total land & building area and value thereof, earmarked for Regional offices of UGC, were not provided to audit.
- (ii) The Commission had shown assets worth Rs. 5.23 crore at the beginning of the year which includes value of old fixed assets of Rs. 2.47 crore. No depreciation had been charged on these fixed assets which resulted in overstatement of Fixed Assets and understatement of Expenditure. This was also pointed out in the previous years.

#### Part—B Inter-University Centres

The University Grants Commission had established six Inter University Centres (IIJCs) under Section 12(ccc) of the UGC Act. The accounts of six IUCs have not been consolidated in the accounts of UGC. In the absence of consolidation and inclusion of IUC transactions/balances, the UGC accounts did not exhibit a complete view of the finances held by UGC/IUCs.

The comments on the accounts of IUCs are given below:-

### Consortium for Educational Communication (CEC), New Delhi

#### A. General

CEC procured Video equipments amounting to Rs. 915.76 lakh during the year 2012-13 and made a payment
of Rs. 903.34 lakh upto March 2013 and balance amount of Rs. 12.42 lakh was withheld for lens and focus
servo zoom problem and non-supply of manual.CEC neither crerated liability for withheld amount of Rs.
12.43 lakh nor disclosed in the Notes on Accounts.

#### B. Grant-in-aid (UGC)

University Grants Commission is mainly financed by the Ministry of Human Resource Development, Department of Secondary and Higher Education. During the year 2012-13 it received grant-in-aid of Rs. 9647.57 crore (Rs. 4960.79 crore under Plan and Rs. 4686.78 crore under Non-Plan. A sum of Rs. 859.41 crore (Plan: Rs. 773.74 crore and Non-Plan: Rs. 85.67 crore) was lying with the Commission unutilised of the previous year 2011-12. Out of total grant of Rs. 10506.98 crore (Plan: Rs. 5734.53 crore and Non-Plan: Rs. 4772.45 crore), it utilized Rs. 10013.32 crore (Plan: Rs. 5307.40 crore and Non-Plan: Rs. 4705.92 crore). leaving a sum of Rs. 493.66 crore (Plan: Rs. 427.13 crore & Non-Plan: Rs. 66.53 crore) as unspent balance.

It also received grant-in-aid from Ministry of Minority Affairs, Ministry of Tribal Affairs and Ministry of Culture of Rs. 66.00 crore, Rs. 45.00 crore and Rs. 1.50 crore respectively. It utilized Rs. 69.37 crore (Rs. 48.67 crore from Ministry of Minority Affairs. Rs. 19.20 crore from Ministry of Tribal Affairs and Rs. 1.50 crore from Ministry of Culture') leaving an unutilised balance of Rs. 43.13 crore (Rs. 17.33 crore of Ministry of Minority Aoairs and Rs. 25.80 crore of Ministry of Tribal Affairs) as on 3 1.3.2013.

No grant from M/o Social Justice & Hmpowemieni was received during 2012-13. Against unspent grant of Rs. 111.36 crore of previous year, UGC utilised Rs. 61.57 lakh during 2012-13 leaving a balance of Rs. 49.79 lakh as on 31st March 2013.

- (ii) As per the information furnished by UGC during the audit of accounts for the year 2011-12 the unspent balance of Plan grant and Non-plan grant as on 31.3.2012 was Rs. 799.47 crore and Rs. 85.04 crore respectively. But in the Utilisation Certificates for the year 2012-13" furnished to audit the opening balances of Plan grant and Non-plan grant has been taken as Rs. 773.74 crore and Rs. 85.67 crore respectively. The difference of Rs. 25.73 crore in the Plan grant and Rs. 0.63 crore in the Non-plan grant needs to be re'conciled' by UGC.
- C. Management letter: Deficiencies which have not been included in the Audit Report have been brought to the notice of the Secretary, UGC through a management letter issued'se'parately for remedial /corrective action.
- v. Subject to our observations in the preceding paragraphs, we report that the Balance Sheet and Income and Expenditure Account and Receipts and Payments Account dealt with by this report are in agreement with the books of accounts.
- vi. In our opinion and to the best of our information and according to the explanation given to us. the said financial statements, read together with the Accounting Policies and Notes on Accounts, and subject to the matters stated above and other matters mentioned in Annexure to this Audit Report, give a true and fair view in conformity with accounting principles generally accepted in India:
  - in so far as it relates to the Balance Sheet of the state of affairs of the University Grants Commission as at 31 March 2013; and
  - in so far as it relate to the Income and Expenditure Account of the deficit for the vear ended on that date.

Pendency of huge amount of audited UCs from 463 State/central universities/deemed universities and educational institutions shows lack of internal control.

As per Rule 292 of General Financial Rules, the advances given for contingent and miscellaneous purposes should be adjusted within fifteen days from the date of drawal of advance. However, contingent advances amounting to Rs. 6.19 lakh were lying unadjusted as of 31.3.2013 pertaining to period 2000-01 to 2011-12 indicating weak controls.

#### 4. System of physical verification of inventory

- Physical verification of consumables of UGC had been conducted upto March 2013.
- The Physical verification of consumables and stationary of IUAC had been conducted upto March 2013 & CEC had been conducted upto 2011-12.

#### 5. Regularity in payment of statutory dues

No payment over six months in respect of statutory dues like provident fund, income tax etc. was outstanding as on 31.3.2013.
