## SECTION-2 (MATTERS RELATING TO STANDARDS)

To consider the issues arising out of the judgement passed by the National Commission for Minority Educational Institutions in respect of Mr. P.A. Inamdar, R/A,963, Nana Peth, Ma-Parvez Road, Pune Maharashtra Vs UGC and University of Pune.

The Bureau may collate the comments and send the same to the MHRD immediately because of the urgency involved in the recruitment of Faculty.

Further the Commission decided that the remaining six issues pointed out in the MHRD's letter dated 28.8.2012 concerning financial implications be looked into by the Sub-Committee expeditiously.

2.04 To consider the Guidelines for Introduction of One Year LL.M. Degree Programme, 2012.

The Commission approved introduction of One Year LL.M. Degree Programme only in such Universities/Institutions which have a Centre for Post-Graduate Legal Studies.
