Department organised guest lecture of Sanjyot Buche, Director, Cognizant Associate with objective to prepare students for the interview in the Cognizant Pvt.Ltd.. Cognizant Associate Director Sanjyot Buche asserted that there is a bright future for students in the field of contract management. Rashtrasant Tukdoji Maharaj was speaking while delivering a guest lecture at Post Graduate Law Department of Nagpur University on Thursday, May 11, 2023. The program organized under the auspices of Post Graduate Law Department, Employment and Training Department, Dr. Head of Post Graduate Law Department. While delivering a guest lecture on contract management, Buche informed the students about its three main areas. He shared his 20 years of experience in the field of contract management. He taught the interview technique which is important in the life of the students. Credentials and self-confidence are very important while going for an interview in any company. While preparing the identity card, the nature of the work experience should be mentioned in it without mentioning only the experience. It should include experience of working under difficult conditions. 95% of the information in the identity card should be as expected by the company.

This makes the interview process smoother and makes your candidature stronger for the respective post. Communication skills must be mastered while facing the interview. At this time, you are expected to have a list of important questions ready and prepare accordingly. He also explained the importance of presentation in the interview. If you start interviewing with questions related to the position, you are 50% done. Buche also advised proving yourself at every stage of the interview.

Speaking further in the guest lecture, he elaborated on contract life cycle management (CLM). He explained various aspects related to contract management. Apart from this, he gave information about various types of services like IT services, tax, invoice. Buche said that studying various aspects of contract management can make one a good contract manager. Before facing any legal process one should understand the subject. After understanding everything, be prepared for the case, he advised. Buche also answered the questions asked by the students. Department Head Dr. Payal Thaorey gave information about guest lecturer Sanjyot Buche. Moreover, she said that presentation is more important in the interview. He thanked the chief guests who attended the event. The program was attended by a large number of teachers, non-teaching staff and students of the department.
