**Understanding Mutual Funds:** Mr. Chhari explained the concept of mutual funds, their types, and how they work, making complex topics accessible to the audience.

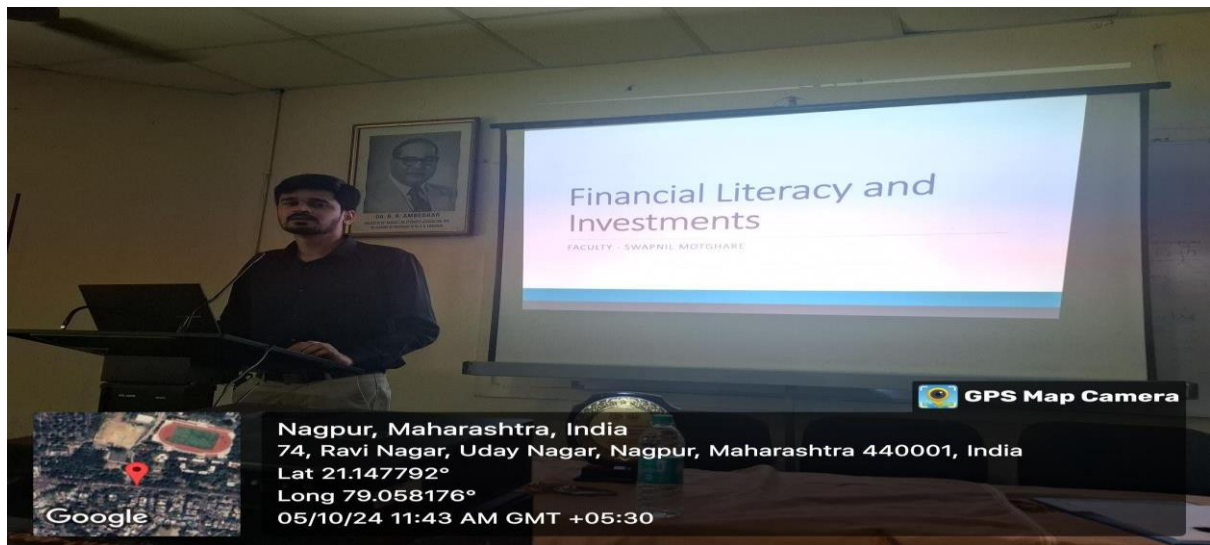
**Investment Strategies:** He shared effective investment strategies tailored to different financial goals and risk appetites, encouraging participants to assess their own financial situations before investing.
