On 24th March, 2022, The Post Graduate Teaching Department (PGTD) of Law, Rashtrasant Tukadoji Maharaj Nagpur University (RTMNU) organises National Webinar on " **Modern Corporate Insolvency Regime in India: A Review** " from 03:00 p.m. to 04:00 p.m. For this webinar, Resource person was Prof. (Dr.) Vijay Kumar Singh, Dean, UPES School of Law, Dehradun. The Webinar was conducted by Dr. Payal Thaorey, Head and Assistant Professor of PGTD of Law, RTM Nagpur University, Nagpur.

The introductory speech was given by the Co- convener of the Webinar Mrs Padma Chobe, Assistant Professor of PGTD of Law, RTM Nagpur University, Nagpur. Dr. Payal Thaorey, delivered the welcome address as well as moderated the whole Webinar. Mr. Saurabh Kumar Singh introduced the Resource Person i.e. Prof. (Dr.) Vijay Kumar Singh, Dean, UPES School of Law, Dehradun.

Prof. (Dr.) Vijay Kumar Singh started with the explanation of Insolvency and Bankruptcy Code (IBC) and the Corporate Insolvency Resolution Process (CIRP). He further explained that need to have an effective insolvency regime is nothing but a critical component of ease of doing business. Because this helps in not only the revival and rehabilitation of the companies from their financial troubles but also to

safeguarding the interest of the stakeholders namely creditors, shareholders, government, etc. resulting in the overall growth of the economy.

He also explained in detail the meaning of The Ease Of Doing Business as per World Bank with emphasis on the 11 areas of business regulation.

Further he explained the need for the code. Later on he discussed the case of BHEL vs Arunachalam Sugar Mills Ltd., (High Court of Madras), O.S. A. Nos. 58, 59, 63, 64 and 81 of 2011 that was decided on 12.04.2011.

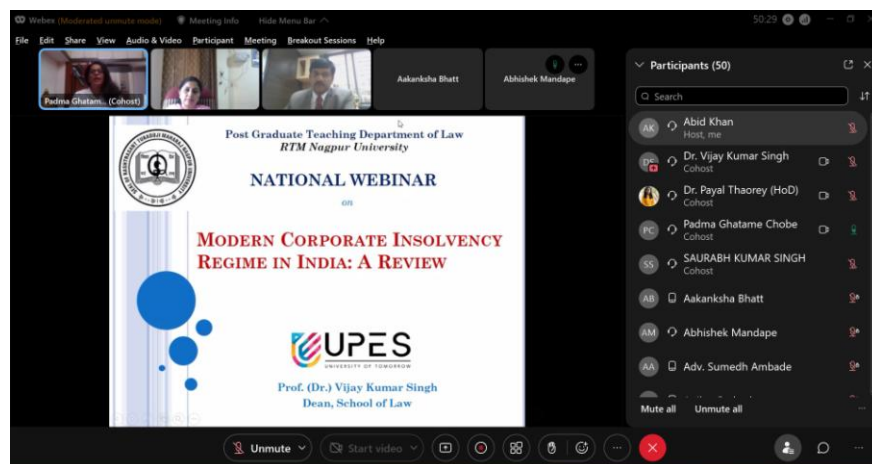
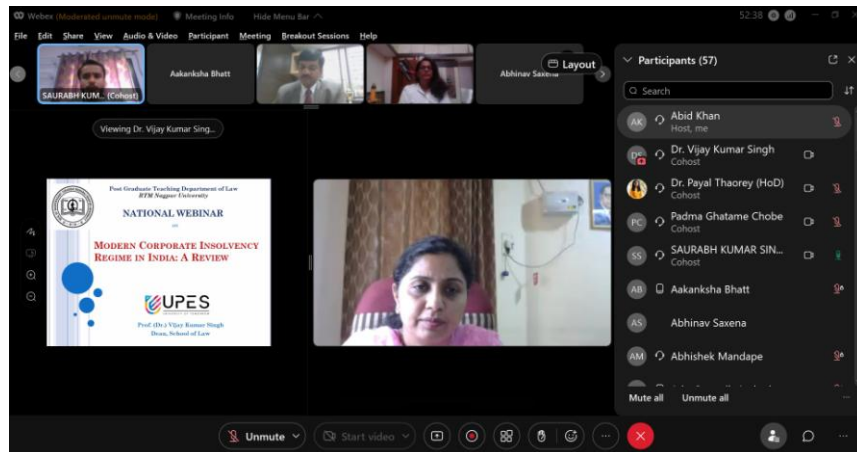
Later on he explained the creditor's perspective and the need to have a modern corporate insolvency code and the principle behind the code.

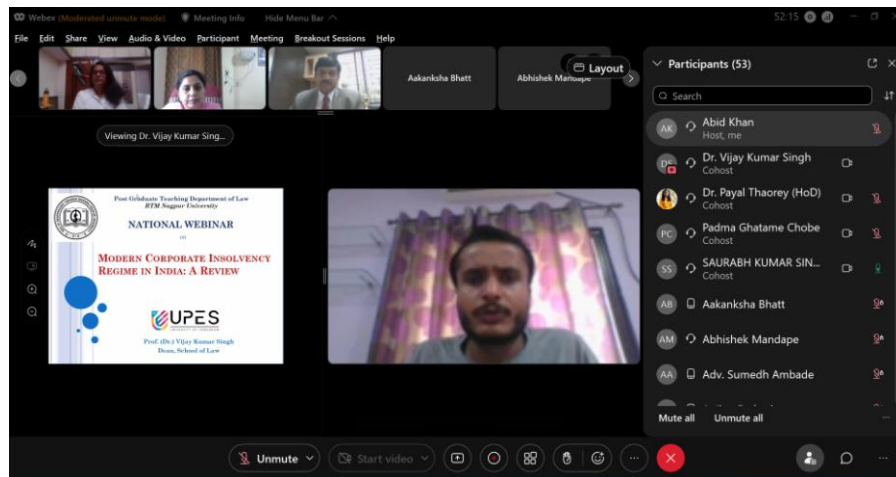
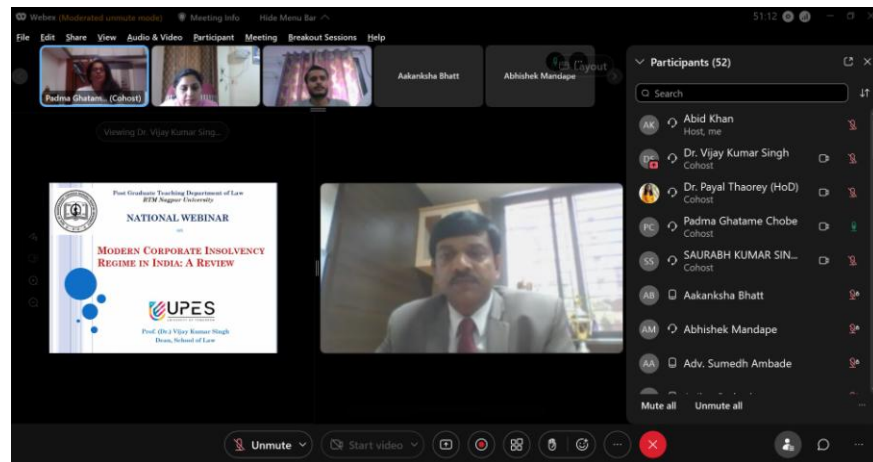
He also gave a brief overview of the code and also explained about the adjudicating authorities involved in the process of the insolvency and liquidation of the companies.
