### REPORT

### Guest lecture on Philosophy of Indian constitution

*on 4-12-2023 at 10:30 am*

Post Graduate Teaching Department of Law (Autonomous), RTMNU organized a guest lecture on the topic of 'Philosophy of the Indian Constitution' on 4<sup>th</sup> December 2023 at 10:30 am in the department premises. This lecture was attended by the students, non-teaching staff, and faculties of the PGTD Law. Mr. Tariq Khan, an alumni of PGTD of Law was invited as a speaker to enlighten the students on this topic. Mrs. Richa Kochar, faculty at PGTD of Law, RTMNU formally introduced the resource person and Dr. Payal Thaorey, Head PGTD of Law welcomed the guest speaker and introduced the importance of the Constitution in Indian perspective to the audience.

The eminent speaker, Mr. Khan, shared his valuable insight, especially pointing out the importance of the constitutional setup under the Indian system and even worldwide mentioning that it is understood with the standard of rights that are given to citizens. He opined that Constitutionalism isn't related to individual provisions but it is a broader goal within which constitutional set up is covered. Both concepts may not exist simultaneously ex. In Korea but in the Indian system constitutionalism is a way to make the constitution effective, to ensure protection from discrimination and injustice. He stated that the list of 448 articles is competent enough to cover every aspect required, making the Indian constitution perfect in the speaker's opinion. He further added that the Indian constitution is a brainchild of real visionaries the same is evident from the debates and deliberations of the Constitutional assembly. Simple features and experiences of concepts of the right to life, division of pre and post-constitutional laws, the predominance of legal spirit reflected under Art 13, the importance of affirmative action for all under the equality concept, complementary justice under Art 16, etc have made the development and stability of nation a great reality.

He categorically emphasized that The Constitution supersedes the authorities, not just a ruling 'person' but also other authorities. The development of education as a fundamental right coupled with fundamental duties and DPSP is a feather in the cap. The concept of DPSP borrowed from Ireland, of rule of law borrowed from the United Kingdom, fundamental rights borrowed from the United States, and South Africa's concept of amendments are the best features picked to adjust in the Indian setup. It is the responsibility of every citizen to safeguard and protect this constitution and fulfill their fundamental duties. A notable point insisted by the eminent speaker was that "Law is a weapon but needs to be

enshrined in constitutional spirit". He proposed that these aspects need to reach the ground level for every person and lawyers today need to take this responsibility to ensure affirmative application.

A formal questions and answer session was conducted at the end of the session, wherein the students asked some important questions if there is any contemporary relevance of the constitutionalism concept? How the failure of law enforcement shall be curbed with the effective implementation of constitutional provisions? The resource person successfully answered the quires and the students were satisfied with her answer. The program ended on a positive note. A formal vote of thanks was proposed by Ms. Shivani Khandate.


