Order Delivered on 15/06/2024

1. The Applicant approached this Grievances Committee under Section 79 of the Maharashtra Public Universities Act, 2016 with a prayer to claim relief for her grievances. The facts giving rise to Grievances and to claim relief are as under.
2. The Applicant was appointed as a Lecturer on 10.06.2011 in the college of Non-Applicant and she had joined the duties on 11.06.2011. She was promoted as an Assistant Professor on

27.02.2012 and thereafter as an Associate Professor on 05.04.2016. The approval to the appointment of the Applicant was granted by Rashtrasant Tukadoji Maharaj Nagpur University on 19.03.2013 from the session 2012-13. The Applicant has filed the copy of approval letter dated 19.03.2013.

3. It is submitted by the Applicant that the Non-Applicants had not released her salary as per the recommendations of 6th & 7th Pay Commission. It is submitted that the Council for Architecture has adopted the pay scale as recommended by 6th & 7th Pay Commission and also recommended by UGC and adopted by AICTE. It is further submitted that the State Govt. of Maharashtra has also prepared the policy as per the Govt. Resolution dated 12.08.2009 and State Govt. has also issued Govt. Resolution dated 11.09.2019 and thereby the pay scale of 7th Pay Commission has been made applicable. The Applicant has filed the copies of Govt. Resolutions on record.

4. It is further submitted by the Applicant that she had preferred the Writ Petition No. 1024/2023 before the Hon'ble High Court, Bench at Nagpur for implementing the recommendations of 6th & 7th Pay Commission and by order dated 14.02.2023, Hon'ble High Court disposed of the petition and directed to approach the Grievances Committee. The Applicant has filed the copy of the order dated 14.02.2023 on record.

5. The Applicant has prayed for directing the Non-Applicant No. 1 & 2 to fix the pay as per the recommendations of 6th & 7th Pay Commission and to release the arrears with interest @ 18% per annum.

6. The notices were issued to the Non-Applicants to appear but they did not file reply as during the proceeding it was submitted by the Non-Applicants that matter is settled with the Applicant in




respect of her claim and deed of settlement was prepared as per the terms of compromise and on 01.06.2024, the Applicant and Administrative Officer of the Non-Applicant college were present and they have also filed the deed of settlement and they have admitted that the deed of settlement is signed by the Applicant and also by the Secretary of the Non-Applicant Institution. And the parties have admitted the contents of the deed of settlement as correct and they agreed to the terms and conditions mentioned in the deed of settlement.




