Publication Policy

The *RTMNU Law Journal*, published by the Post Graduate Teaching Department of Law, Rashtrasant Tukadoji Maharaj Nagpur University, is a premier academic publication that fosters and advances high-quality legal scholarship. With a focus on rigorous, innovative, and impactful legal research, the journal offers a critical platform for legal scholars, practitioners, and students to engage in meaningful analysis of contemporary legal issues, providing fresh insights and contributing to a deeper understanding of both national and international legal landscapes.

The journal emphasizes original and critical research that advances intellectual discourse and explores complex legal problems, emerging issues, and evolving doctrines. By publishing articles that examine and interpret significant legal developments, the *RTMNU Law Journal* aims to shape discussions around the interpretation, application, and evolution of law. This approach not only benefits the academic community but also assists policymakers, judges, and practitioners in making informed, research-backed decisions that influence the development of law and policy.

The journal's commitment to scholarly excellence is reflected in its peer-review process, which employs a double-blind system to ensure thorough and impartial evaluation of each manuscript. This policy safeguards both author and reviewer anonymity, promoting unbiased feedback and maintaining the quality, originality, and academic integrity of the journal's published works. Through this stringent review process, the *RTMNU Law Journal* guarantees that each published article meets high standards of scholarly rigor and makes a substantial contribution to the ongoing dialogue within the legal community.

Publication Policy:

The RTMNU Law Journal welcomes a wide spectrum of legal and interdisciplinary submissions, encompassing the following categories:

- Research Articles: In-depth scholarly analyses of specific legal issues, providing original insights, theoretical advancements, and interpretations.
- Case Comments: Critical evaluations of recent court decisions that assess the legal, social, and policy implications of key rulings.
- **Book Reviews**: Evaluations of newly published books relevant to the field of law, examining the book's contributions, methodology, and relevance to legal scholarship.
- Legislative Reviews and Critiques: Analyses of legislative developments that explore the impact and practical application of new or amended statutes and regulations.

The *RTMNU Law Journal* accepts submissions on a rolling basis, meaning there are no specific deadlines. Authors may submit their manuscripts at any time throughout the year.

Academic Integrity and Originality:

1) Originality:

Manuscripts submitted to the *RTMNU Law Journal* must be original, unpublished works. They should not be under consideration for publication elsewhere. Authors are expected to uphold high standards of academic integrity, and any form of plagiarism is strictly prohibited. Authors must ensure that their work is free from duplicate content, and direct quotations and borrowed ideas should be properly cited.

2) Copyright:

Upon publication, the *RTMNU Law Journal* holds exclusive copyright over all published materials. Authors must agree that, apart from fair use for research, private study, or critique, no part of the journal content shall be reproduced, adapted, stored, or shared in any form or by any means without prior written permission from the journal. This provision safeguards intellectual property rights and ensures the journal's contributions remain unique and authoritative.

Review Process:

The *RTMNU Law Journal* follows a comprehensive, multi-stage review process designed to maintain the highest standards of quality and credibility in its publications:

1) Initial Screening:

Each submission is first reviewed by the editorial board to verify that the draft aligns with the journal's standards of quality, relevance, and format. At this stage, the manuscript is checked for adherence to submission guidelines, such as citation style, formatting, word limits, and general academic quality.

2) Plagiarism Check:

Submissions undergo a thorough plagiarism check to confirm originality. Only manuscripts with a similarity index below 30% are allowed to proceed to the next stage. Authors are encouraged to ensure compliance with this criterion before submission to expedite the review process.

3) Double-Blind Peer Review:

Manuscripts that pass the initial screening and plagiarism check are forwarded to experts in the field for a double-blind peer review. In this process, both authors and reviewers remain anonymous to each other to ensure impartiality. Reviewers evaluate each manuscript on various parameters, including:

- Originality and innovation
- Coherence and structure
- Language and clarity
- Relevance and significance of the topic
- Comprehensiveness of research
- Contribution to existing knowledge and scholarship

This rigorous peer-review process upholds the journal's scholarly standards and ensures that all published work contributes meaningfully to the field of legal scholarship.

4) Notification and Feedback:

Following the review, authors are notified of the outcome and provided with constructive feedback at each stage of the review process. Based on reviewer comments, manuscripts may be accepted, rejected, or returned to the authors for revision. Authors may be requested to make changes to improve the manuscript in terms of clarity, depth of analysis, or adherence to journal guidelines. The entire review process typically takes 6–8 months, depending on the volume of submissions and the complexity of the review required.

Through this multi-layered review process, the *RTMNU Law Journal* ensures that published works reflect thorough, high-quality research that advances the understanding and application of law. This careful and detailed review structure is designed to support authors in refining their research while ensuring that the journal consistently publishes material that meets the highest academic standards.
