Report of Webinar

On 28th February, 2022, Centre for Women's studies and Development RTMNU in association with the Post Graduate Teaching Department (PGTD) of Law, RTMNU organises National Webinar on "**Rights of Women under Personal Law**" from 12:30 p.m. to 02:30 p.m. For this webinar, Resource person was Dr. Shahista Inamdar, Principal, Navjeevan Law college, Nasik. The Webinar was conducted by Dr. Vijayata G Uikey, Director (In-charge) Centre For Women's Studies and Development, & Assistant Professor, PGTD of LAW, RTMNU. Dr. Payal Thaorey, Head and Assistant Professor of PGTD of Law, RTM Nagpur University, Nagpur. Dr. Vijayata Uikey, delivered the welcome address as well as moderated the whole Webinar. Ms. Yogita introduced the Resource Person i.e. Dr. Shahista Inamdar, Principal, Navjeevan Law college, Nasik.

Dr Shahista Inamdar who is also a brand ambassador of women empowerment started with the term equality that is offered by our Constitution to the men and women. She tried to be more interactive with the participants. She raised the issue of hijab and the problems that are faced by the Muslim women because of the personal laws that are somewhere misinterpreted and misrepresented by the clerics.

She cited various cases where the misinterpretation of the personal laws have violated the constitution of India. Few of the cases she mentioned in her talk were Imrana Rape Case that happened in the year 2005 where she was raped by her father-in-law at gun point in Uttar Pradesh. But as per the personal law the Muslim clerics cited the provisions and misinterpreted rape into adultery by the women herself.

Another case was of Bhanwari Devi where Bhanwari Devi, a Social worker was gangraped by five men to stop her from doing social work.

She also discussed the section 5 Muslim Women Protection of Rights and Divorce Act 1985 and section 125 of CrPC.

She also mentioned the Sarla Mudgal Vs Union of India 1995 case, Ahmedabad Women Action Group v UOI 1997, Yusuf Abdul Aziz Vs the State of Bombay 1954 on section 497 of the IPC, Mohd Ahmed Khan Vs Shahbano Begum Case, etc.

She insisted that the right to religion is a part of our constitution and that it must be respected but it is the need of the hour to revoke the ill part of Personal Laws because article 13 (3) of our Constitution states that those part which infringes fundamental rights must be abrogated. She also insisted on the need of the Uniform Civil Code which is now the need of the hour.

The Webinar was concluded by a question-answer session relating to the topic where the resource person had enthusiastically answered the queries of various participants. Dr. Payal Thaorey, Head and Assistant Professor of PGTD of Law, Nagpur proposed the formal vote of thanks for the Webinar. This Webinar was attended by more than 200 participants and received a huge response as well as wonderful feedback from numerous participants across the country. The students of every stream from science to law actively participated in the webinar. Their constant support in maintaining the decorum is also well noticed. The students keenly listened and chalked out the highlights from the invited guests' insights.




